### Space Requirements

Frontage space is sold in 5' increments with a 10' minimum. Please include all space required for trailer hitches, open awnings, and serving areas. Depth of space varies by location. Most spaces are 10' to 20' in depth. Vendors requiring more than 20' in depth will be subject to additional charges.

\* Northeast District Department of Health (NDDH) Permit fee for food vendors only: Multiple booths must pay for multiple permits. NDDH will waive one (1) permit fee for any U.S. Veteran who owns and operates a food concession (Copy of DD214 required and veteran must be listed as owner).

- A late fee of \$100 will be added to all past due balances.
- All fees must be paid in full by June 30, 2023.
- Checks returned for insufficient funds will incur a \$25 fee.
